Re: Importing DRCOG data into OpenStreetMap

Dear Open Street Map Foundation:

The Denver Regional Council of Governments purchases planimetric data in partnership with several local governments and regional partners. DRCOG owns this data and has determined, in writing with all its partners, that the data exists in the public domain and can be made available for free download from our website, the Regional Data Catalog. All datasets are subject to Terms of Use referenced in the metadata of each data available on this website.

DRCOG wishes to provide a subset of the planimetric datasets – building roofprints and sidewalk centerlines – to OpenStreetMap (OSM) because we believe the OSM community can add substantial value to our end product. DRCOG has read and accepts the Open Database License that applies to all data in the OSM database and the License/Contributor Terms required by the OpenStreetMap Foundation.

For the specific purpose of use in OpenStreetMap, DRCOG provides the building roofprints and sidewalk centerline data to OSM volunteers, amends the website Terms of Use, and adds a License Agreement, as follows:
