

ODOT warrants that it is the creator, sole owner or controller of the Material, that it is entitled to assign the rights the subject of this agreement and otherwise enter into this agreement and that the consent of no other party is required in order that Minh Nguyen and any persons affiliated with the Project may use and reproduce the Material in the manner described in this Agreement.
3. Minh Nguyen and all employees, servants, licensees, successors and assigns of the Project agree to release ODOT and its officials, employees, agents and servants, personally and in their official capacity, for all claims, actions, demands, costs, or damages they may have against the State of Ohio, Ohio Department of Transportation, arising out of the use of the Material. In addition, Minh Nguyen agrees to be responsible and assume liability for their own wrongful or negligent acts or omissions, or those of any agents or employees to the full extent required by law.
